

GRAFFONT™ WEB FONT END USER LICENSE AGREEMENT

Please note this document may be updated at any time. We recommend that you print and/or download a copy of this license for future reference.

Overview

This license includes coverage for hosting and using Graffont fonts for live text on a single website.

The Nitty Gritty

THIS IS A BINDING LEGAL AGREEMENT. Please read this Agreement before purchasing, downloading, installing or using the Font Software; any of these actions shall indicate your express agreement to the terms and conditions of this Agreement. If you do not agree to the terms and conditions, you are not permitted to install or Use the Font Software.

PARTIES

This End User License Agreement (the “Agreement” or “License”) is between You and SixAbove Studios, LLC, d/b/a Graffont (“Graffont”, “We” or “Us”).

DEFINITIONS

“Graffont”, “We” or “Us” refers to Graffont, a registered trade name of SixAbove Studios, LLC.

“You” and “Your” refer to the customer (individual, company, or organization) who has purchased a License to Use the Font Software. An End User is not defined as a distributor, reseller, dealer, sub-licensee, wholesale buyer or any similar entity. Graffont’s Fonts may not be distributed and/or sold to third parties without prior written consent from Graffont.

“Font”, “Fonts” or “Font Software” have identical meanings in this agreement. They are defined as the designs of the Fonts and the Software necessary to produce typographic designs and/or any other artworks that may be associated with the Font.

“Use” means to install and access the Font Software by typing characters on a keyboard and/or viewing the digitized characters on a monitor or other Device.

“End User” or “User” means an individual giving commands (by keyboard or otherwise) to a Device on which the Font Software is installed.

“Sales Receipt” means the electronic document You receive as confirmation of the License purchased.

“Static” refers to Use of the Font Software in a format that only permits the viewing or display of the text, and which does not permit the editing of text (i.e., Raster JPEG or PNG images and outlined vector files, such as SVG or EPS).

“License Upgrade” means the purchase additional Licensing to reflect the increase in Your Use/consumption of the Fonts.

“Domain Name” or “Domain” means the address where Internet users can access your website.

“Website” means a group of related web pages organized under a particular domain name, including subdomains, which are owned and controlled by You.

“Pageviews” is a unit used to measure traffic to your web pages. Pageviews must have the ability to be tracked or recorded by a commonly accepted or recognized web statistics tracking system (such as Google Analytics).

1. LICENSE AND FEE

Upon receipt of the License fee, Your Domain Name (Website URL specified by You at the time of purchase, as indicated on Your Sales Receipt) will become licensed to Use the Font Software. You are not purchasing the Font, or Font Software, only the right to Use the Font Software as expressly permitted in this agreement. All rights that are not specifically granted under this Agreement are reserved by Graffont. If you exceed your currently licensed tier (i.e., number of monthly Pageviews), you must purchase a License Upgrade that reflects the correct tier. You may be asked at the time of purchase, or in the future, to provide documentation proving that Your number of Pageviews corresponds with your License tier.

2. GRANT OF LICENSE

This License to Use Graffont’s Font Software grants You a limited, non-exclusive, non-transferable and terminable right to use the Font Software permitted your Use is in accordance with the terms and conditions of this Agreement.

3. END USER LICENSE REQUIRED

The individual or organization indicated on Your Sales Receipt is the licensed End User of the Font Software. Please note this license is for Website owners developing their own Website. If pursuant to this License You use the Font Software to develop a Website into which the Font Software will be embedded or used by any unlicensed party, such as a client or customer, the unlicensed party must purchase their own License to display, reproduce or otherwise Use the Font Software in connection with the End User’s brand or business. You agree to notify the unlicensed party that they must purchase their own License. Alternatively, You may purchase a License on their behalf, so long as their name or organization is indicated on the Sales Receipt. Use of the Font Software, or artwork or text created by the Font Software, by an unlicensed party shall constitute a breach of this License Agreement, causing significant monetary harm to Graffont.

4. INSTALLATION

4.1 Single Domain - You may install and Use the Font Software to create, style, edit and display text via the @font-face selector in CSS at a single Domain Name (including sub-pages located at that same Domain Name) specified by You as the Website URL at time of purchase, provided the URL and Website are owned and controlled by You.

4.2 Notice to Users - You agree to inform any User having access to Graffont's Font Software and copies thereof, of the terms and conditions of this License Agreement and to ensure that these terms and conditions are abided.

4.3 File Protection - You agree to adequately secure the Font Software to prevent access and/or use by unlicensed third-parties and/or other websites. This includes prevention against hotlinking or direct access via web server integration or other. If You discover or are made aware of any unauthorized access and/or use by an unlicensed third party, You shall immediately notify Graffont, in writing, of this unauthorized access and/or use.

PERMITTED USES

This License grants you the right, as set forth above, to use the Font Software to create, style, edit and display HTML documents at the Domain specified by You, provided that you (I) own and control the Domain and (II) you do not exceed the monthly Pageviews.

5.1 Pageviews - This License is limited by the amount of monthly Pageviews specified by You at the time of purchase, as indicated on Your Sales Receipt. In the event that your Pageviews exceed the amount designated on Your Sales Receipt, you must purchase a License Upgrade to allow for those additional monthly Pageviews. Failure to purchase the proper license for such uses shall constitute a breach of this License Agreement, causing significant monetary harm to Graffont.

5.2 Website Developer - You may temporarily supply a single copy of the Font Software to an individual website developer or similar agent for the purpose of producing a "permitted use" of the Font Software exclusively for You. Upon completion of production of this permitted use, the website developer must immediately delete/destroy the Font Software and You agree to take reasonable steps to ensure this happens.

5.3 Back Up - You may make one (1) back-up copy of the Font Software for archival purposes only. Copies must contain the same documentation, copyright, trademark, and other proprietary notices that appear on, in or with the Font Software. Copies shall be kept secure and only You shall retain exclusive custody and control over such copies. Upon termination of this Agreement, you must destroy the original and any and all copies of the Font Software.

5.4 Other Use - All other uses not expressly permitted under this Agreement are prohibited and exclusively reserved to Graffont.

6. GENERAL RESTRICTIONS

6.1 Transfer - You may not rent, lease, sublicense, give, lend, or otherwise distribute the Font Software, or any copy thereof (except as specifically permitted in this Agreement)

6.2 Modification - You may not modify, alter, adapt, translate, reverse engineer, decompile, disassemble, or attempt to discover the source code of the Font Software without prior written consent from Graffont. You do not have any rights to change the Font Software to a different format other than that provided.

6.3 Third Parties - You may NOT share a copy of the Font Software or an embedded version of the Font Software with any third party (apart from an individual website developer, as

provided above). If You are a designer, or design organization, whose client or any other third party requests or requires use of the Font Software – in embedded form or otherwise - your client or such third party will need to purchase its own License to Use the Font Software.

7. SPECIFIC RESTRICTIONS

Use of Graffont Fonts and designs embodied in the Font Software are not permitted in the following circumstances or applications without purchasing a License Upgrade. Failure to purchase the proper license for such uses shall constitute a breach of this License Agreement, causing significant monetary harm to Graffont.

7.1 Desktop and Static Use - This is not a "Desktop" License. You agree that you will NOT use the Font Software (I) to create documents, logos, graphic signage or other printed materials, or (II) in any Static digital materials, including the use of Static imagery for Websites or HTML banners. Any of these uses shall require a License Upgrade.

7.2 Other Embedding - This is not an "Application" or "ePub" license. You agree that you will NOT embed the Font Software into any software application (web-based or otherwise), electronic publication or document. Any of these uses shall require a License Upgrade.

7.3 Broadcast - You agree that you will NOT use Font Software to create text that will be displayed or used in audio-visual works (including video) broadcast via network, cable, satellite or other television, any online subscription-based services (such as Netflix or Hulu), pre-roll video for YouTube or other video sites, or videos broadcast or made available on social media platforms. Any of these uses shall require a License Upgrade.

8. COPYRIGHT

8.1 Ownership - The Font, designs embodied in the Font Software and any accompanying documents are the exclusive property of Graffont and/or its designers, and are protected by the copyright, trademark and other intellectual property laws of the United States, by the copyright and design laws of other nations, and by other international treaties. Possession of the Font Software does not grant any right, title or interest in and to the design of the Font or the Font Software itself.

8.2 Design Credit - If you use the Font Software in a manner or for a purpose where design credits are displayed, You shall credit Graffont as the trademark owner, copyright owner and creator of the Graffont Fonts, in the following manner: (Font Name) © Graffont – www.graffont.com

9. WARRANTY & LIABILITIES

9.1 Warranty - THE FONT SOFTWARE IS PROVIDED "AS-IS". GRAFFONT MAKES NO WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO NON-INFRINGEMENT OF THIRD PARTY RIGHTS, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. The entire risk as to the quality and performance of the Font Software rests upon you. Graffont makes no warranty that the function of the Fonts will meet your requirements or that the operation of the software will be uninterrupted or error free.

9.2 Limitation of Liability - TO THE EXTENT NOT PROHIBITED BY LAW, IN NO EVENT SHALL GRAFFONT BE LIABLE FOR ANY DIRECT, INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES (INCLUDING, WITHOUT LIMITATION, DAMAGES FROM LOSS OF PROFITS, LOSS OF DATA, BUSINESS INTERRUPTION, AND THE LIKE) ARISING OUT OF THE USE OF OR INABILITY TO USE THE FONT SOFTWARE, EVEN

IF GRAFFONT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. This limitation may not apply in some jurisdictions.

10. MISUSE (OR BREACH OF CONTRACT) & TERMINATION

10.1 Misuse of Font Software - Use of Fonts without license or adequate licensing shall require a license to be paid for the usage of the Font Software retroactively. Graffont reserves the right to charge as it sees fit for time, expenses and legal work undertaken.

10.2 Termination - Graffont reserves the right to terminate this Agreement at any time. Termination will be effective immediately upon written notice from Graffont (which may be given by email) and we will revoke the license for the purchased Fonts without refund. Upon termination of this Agreement for any reason, you must delete or otherwise destroy the Font Software and any derivatives of such software in your possession and control, and you shall promptly submit a declaration, signed by an officer of your organization (or you, if use is personal), certifying such destruction and/or deletion, and further certifying that the Font Software has not been made available by you to any unlicensed person or third party. The termination of this or any other Agreement by Graffont will be without prejudice to Graffont's entitlement to damages in connection with any violation of this Agreement.

11. MISCELLANEOUS/LEGAL

11.1 Governing Law - This Agreement is governed by the laws of Connecticut, without regard to Connecticut's conflict or choice of law provisions. You hereby expressly consent to the personal jurisdiction of the local, state or federal courts selected by Graffont for the hearing or resolution of any dispute or action arising out of or related to this Agreement. You further agree that you will not initiate, participate in or join as a class member, any class action or arbitration proceeding arising from or relating to this Agreement or the Font Software.

11.2 Severability - If any term of this Agreement is to any extent illegal, otherwise invalid, or incapable of being enforced, such term shall be excluded to the extent of such invalidity or unenforceability; all other terms hereof shall remain in full force and effect; and, to the extent permitted and possible, the invalid or unenforceable term shall be deemed replaced by a term that is valid and enforceable and that comes closest to expressing the intention of such invalid or unenforceable term.

11.3 Audit - Graffont may, at any time, request an audit in order to confirm the licensed Website and number of monthly Pageviews matches Your Sales Receipt, and that your Use of the Font Software is in compliance with the terms of this Agreement. Within seven (7) days of receiving a Notice of Audit from Graffont, you shall provide a certified statement of the computers, servers, websites, applications or other sources where the Font Software may reside, be saved or be accessed, and proof that you are in compliance with Your monthly Pageview limitations. You shall permit Graffont or its designated agent to inspect (in person or via remote access) the Font Software and your facilities, machines, and records to verify your compliance with this Agreement. In the event the audit reveals any noncompliance, Your License may be terminated and You agree to retroactively settle with the appropriate License and License tier by paying in full for the usage. The obligations and terms set forth in this section will survive termination of this Agreement for a period of one (1) year.

11.4 Amendments - Graffont reserves the right to amend or modify this Agreement at any time and without prior notification. Any modifications will preserve the original permitted uses of this Agreement. Modifications may account for changes in technology that would otherwise impair or render obsolete provisions in this Agreement. Modifications shall not be applied retroactively and any original intended use cases will not be void as a result of any modifications. Graffont will make such amended terms available at www.graffont.com. If You do not agree to the modified terms, Your continued use of the Font Software could be in breach of the Agreement.

11.5 Termination/Fees - In the event that you violate this Agreement, you agree to pay Graffont's reasonable attorneys' fees incurred in connection with any audit, action or proceeding relating to such violation. This provision will survive termination of this Agreement for any reason.

11.6 Waiver - Graffont's failure to enforce any provision of this Agreement shall not constitute a waiver of any other provision of this Agreement. Furthermore, no waiver of any term, provision or right set forth in this Agreement will be effective unless provided in writing and signed by the party against whom the waiver is to be enforced.
